

Riverbend Golf Club Inc.
Board of Directors Meeting - Meeting Minutes
November 20, 2023

The BOD meeting was called to order at 3:02 pm by President Kevin Kennelley.

Liz Haney, Secretary confirmed the meeting was properly warned and we had a quorum present.

Minutes Approval: The minutes of the October 16, 2023, Golf Board meeting were approved as submitted.

President's Report

The Riverbend Lightning Alarm signals have been updated to be in synchronization with other courses in our area. When you hear one (1) long blast, lightning has been detected in the area and it is mandatory that you must leave the course immediately and seek safety. Do not go to the Halfway House as it is not safe from a lightning hit. When it is safe to return to the course, you will hear three (3) short blasts. This indicates there is no lightning in the area and it is safe to return to the course and resume your golf game.

For everyone's safety, we do not allow "walking" on the golf course. A recent incident occurred when a Riverbend resident was walking (not playing golf) across the middle of the driving range to meet with a friend on the other side of the course. A member practicing on the driving range hit a ball and stuck the member walking across the driving range in the head.

Safety is one of the Golf Boards top priorities. Rules are in place for our members safety, please follow the rules and pay attention when you are out playing golf on the course.

Treasurer's Report

The financial statement for October 2023, which is the seventh month of our fiscal year, reflects a gain of \$70,521. The Golf Club had total cash on hand of \$853,953 on October 31, 2023.

To date, October quarterly maintenance fees have been paid by all but 19 of the membership. Two accounts are in foreclosure, three have liens filed and the remaining 14 accounts are expected to remit payment without attorney involvement.
