Riverbend Golf Club Inc. Board of Directors Meeting - Meeting Minutes September 18, 2023

The BOD meeting was called to order at 3:00 pm by President Kevin Kennelley.

Present: Kevin Kennelley, Rosalie Deitz, John Melson, Ken Kotansky, Bill Barry, Chuck Howard, Elizabeth Mard (Board of Directors)

Liz Haney, Secretary confirmed the meeting was properly warned and we had a quorum present.

Minutes Approval: The minutes of the July 17 were not available and will be approved at the October 16, 2023 board meeting.

President's Report

On 9/11 Riverbend Golf Club hosted the Wounded Warrior Golf Tournament with 20 4-person teams. Over \$11,000 was raised for the Wounded Warrior project from the tournament entry fees and raffle prizes donated by generous support of our sponsors and individual teams. A big thank you to the committee, the volunteers and all those individuals who donated to this cause.

Our rounds of golf have been down over the summer due to hot weather, humidity, and rain. Therefore, the Golf Board elected to close on Thursdays and will look at other options to trim the budget since we are facing lower revenues for the summer. However, we have our "season" ahead of us and with the course in good condition, thanks to Jeff and the course maintenance team, we are looking forward to a good 2023/24 season.

Treasurer's Report

The financial statement for July 2023, which is the fourth month of our fiscal year, reflects a loss of \$2,172. The Golf Club had total cash on hand of \$833,411 on July 31, 2023.

To date, July quarterly maintenance fees have been paid by all but 20 of the membership. One account is in foreclosure and three will go to lien if not paid by September 18, 2023. The remaining 16 will be sent Notice of Late Assessment letters before the end of the month giving them 30 days to pay before going to collections.

Rounds of golf are down about 10% lower this year than last which is about \$17,000 loss in revenue. However, our Membership numbers are up which bring in more maintenance fees and helps offset the lower rounds for the summer months. The budget is in line and even though the summer tends to be slower when we get into season we should be able to recoup the slow summer losses.

Greens Committee

• Our last greens aerification is scheduled for Tuesday, Sept. 19th. This will be the last time we use an outside contractor for this. In the future, we'll be able to do this in-house, thereby not inconveniencing the members.

- We've had a great deal of rain recently, but the course is in excellent condition. Keeping golf carts off the wet areas will preserve the course for the upcoming winter busy season.
- We did an in-house repair of our large fairway mower, where the blades had been damaged by tree roots and tree debris. Jeff and Jacob re-installed the mower reels resulting in a big cost savings.
- The greenside bunker on #1 is being repaired due to the irrigation pipes being very near the surface.
- A new cart path is being constructed on #8.
- The nursery green has an excellent base of soil and plugs from the next aerification (Sept. 19th) will grow on that surface.
- Tree work is complete. Diseased & invasive species were removed. The large eucalyptus trees do a great deal of damage to our mower blades with their debris and need constant(daily) clean-up. Roots inhibit healthy turf growth and damage our equipment. We will replant with native trees that will not damage our turf or equipment as the budget allows.
- We have a layer of rough to protect the weak areas of the course. Wear and tear from golf cart traffic does damage to our turf (compaction). We have 9 Par 3's that are CART PATH ONLY. By keeping all 4 wheels on the cart path helps the turf.

Diving Range: Since we have a picker cart with cage we can collect range balls during the day. Therefore, the practice range will be closed at 6 pm with the last bucket of balls sold at 4:50 pm. After 6 pm golf members can use their own balls and must pick up their own balls and fill the divots.

Ed Garlick asked the board to explain the difference between the Riverbend owners and other memberships as to who has Voting rights. RB owners, North Passage and Full Members are full equity members and have voting rights. Summer Members and Associates are non-equity members and DO NOT have voting rights. Full Members (equity members) pay 15% more than the Riverbend owners golf dues.
